 Music must be turned off at 1:00 am and all guests vacate the venue and leave the premises by this time. Vendors must be off the premises by 1:30 am A \$500 fine will be applied to the final bill for any guests or vendors on-site past 1:30 am.
- Rental of the reception room is from 8:00 am on the event date to 1:30 am the subsequent day.
 Outside event vendors are to adhere to a high level of service quality and accountability. It must be understood that Sunset Ranch has the final say with any and all final decisions.
- 18% Gratuity will be applied to the final bill & all prices are subject to change.

Guests in attendance: Sunset Ranch Golf & Country Club requires a confirmed number of guests including vendors 2 weeks in advance of your event date. A final billing number is to be received 3 days prior to event date. This number will act as your total minimum number for your event during the billing process. If you have more guests attend, then your final number you will be billed for your actual number of guests attended. In the event of cancellation within 2 weeks of the event date, 50% of the total event cost will be billed.
